In this capacity Jane received and compiled the annual reports of activity from all of the Directors of the CPID into a single annual report of the Division which was presented at the annual Division meeting. This report was also given to the Division Historian for archiving. Jane also recorded and published the minutes of the CPID meeting and luncheon at the annual PSA International Conference. In addition, Jane acted as corresponding secretary for the Division Chairperson on an as needed basis.

Photo-Travel Division Journal Editor 2001 – 2007
In this capacity Jane received and compiled news on PT Division activities from the Division Directors. She edited the material into a suitable format and provided the information on a monthly basis to the Editor of the PSA Journal for publication in the Journal.
