## PSA Liability Insurance - Great Benefit

### PSA Club Service Program at Charleston Conference

On Thursday, October 7, from 11:00 AM to 12 noon, there will be a presentation on "PSA Club Services."

**Joanne Stolte, APSA EPSA, Membership Vice President**, will review all of the PSA club services currently available as well as introduce several new benefits.

All Club Reps and club officers should attend and do invite anyone from your club who is interested in knowing what is new for PSA-member clubs

Why are clubs and councils flocking to the Photographic Society of America (PSA) to take advantage of the new PSA club insurance benefit?

In today's litigious society many club-meeting venues are requiring clubs and councils to purchase expensive liability policies. Membership Vice President, **Joanne Stolte, APSA, EPSA**, has arranged for e-insurance from the Willis North America Company: one of the few companies to tender insurance strictly for photographers.

Does your club currently have general liability insurance? If yes, what is the expiration date? If not, would the club buy it for approximately \$200 annually?

If a club is uninsured and actually responsible for a severe injury, like a blown out knee (\$75,000)

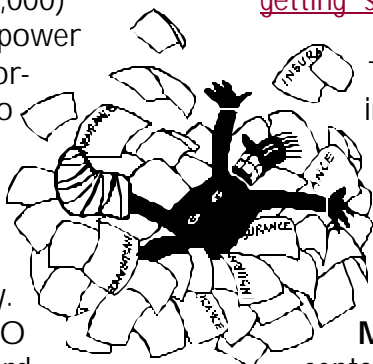
from tripping over a power cord, the plaintiff attorneys would be able to sue the directors or members of the club (Equipment Chairman, person helping to set up) individually.

There could be a D&O exposure for the board members, if they don't have insurance.

The company is offering liability and equipment insurance or liability-only insurance to all PSA clubs and councils in the United States and Canada. And as an added feature, low rate liability and equipment insurance is available to individual PSA members.

The cost of the club liability insurance policy is directly related to the number of events a club has per year: for clubs and councils \$175 covers up to 15 events per year; 16 to 30 events a year is \$235; those holding 31 to 45 events a year pay \$295; while those conducting 46 to 60 pay \$295, and those which have 46 to 60 events per year are charged \$355.

And how much insurance coverage do you get for your money? Comprehensive liability limits: \$1 million Per Occurrence /\$2 million Aggregate; \$2 million Products & Completed Operations Aggregate; \$300,000 Fire Damage Legal Liability and there is no deductible for bodily injury liability claims. **Morgan**, the PSA Club Representative and a member of the Society since 1970 tells us, "The cost started out at \$250.00 per year for \$1million. The cost has been going up each year until this year they wanted \$278.00. We decided to look around and see if it could be had for a lower rate. One night by chance, the president's wife found a notice, in the *PSA Journal*, under the Camera Club News

## PSA International Newsletter Contest 2010 for Chapters, Clubs, & Councils

Almost sixty chapters, clubs, and councils entered this year's PSA International Newsletter Contest. With a size range of from four to forty pages, newsletters were submitted by enthusiastic editors.

heading. I called the PSA office and was given information with a telephone number to call Dale Wittick, the insurance representative. He was very helpful and explained the procedure of getting the policy. When I explained that our present policy expired in three weeks, his comment was 'no problem.' He could take the information over the phone: it would take about 10 minutes and to give him a credit card number, that it could be charged to. He e-mailed me a copy of what the policy covered. Two hours later, that was received and after a discussion with the club president, Wittick was called back and everything was finished up... The new policy cost us only \$175 per year. That gave us a savings of \$103."

*Blair County Photographic Society of Duncansville, Pennsylvania, who's President, Dave Hammaker tells us, "So far my experience with the company providing the insurance has been good. They were very responsive to my requests for information and were able to get the insurance in place almost immediately. Our club had been operating under the assumption that we were covered by another organization's insurance. I was checking into the coverage when I found out we didn't have any coverage. So I was very happy I could get the PSA club-benefit insurance so quickly. We found the cost to be reasonable. Any club that doesn't have insurance should seriously consider this company."*

*The Rockland Photography Club, of Chestnut Ridge, NY, meets in a local*

town facility and is required to have insurance which at one time was costing the club \$764 per year. Although they were able to reduce the cost to \$477, this was still a steep price for a 25-member club that meets approximately 25 times a year. Club treasurer, **Peter Gordy**, tells us that after reading an article in the *PSA Journal*, the club contacted the agent for the Willis North America Company, and was able to buy insurance for a much lower premium of \$235.

**The PSA club insurance benefit is not restricted to camera clubs. Any PSA-member council, or group of camera clubs, whether they call themselves a federation, society, organization, etc., is eligible to participate and buy the club insurance benefit.**

For instance, the *Southern California Council of Camera Clubs (S4C)* was able to reduce their insurance payments by approximately half. S4C has a membership of 12 clubs and meets approximately 10 times a year at the California Baptist University in Riverside, California. **Stuart Lynn**, a PSA member and President of S4C tell us that, "We're delighted with the new program."

- \* Do you bring several copies of

the PSA Individual Membership Handout with you to each club meeting?

If you cannot complete the tasks of the PSA Club Representative for your club, please find someone else who can fill this significant role in the club.

Make sure your club is getting all the member benefit information that PSA sends to member clubs via the PSA Club Representative.
